Day Camp For Dogs, LLC, or otherwise while my pet is under the care of Run! Day Camp For Dogs, LLC.

1. I agree to indemnify Run! Day Camp For Dogs, LLC for any loss, liability, damage, or cost they may incur due to my presence or the presence of my pet in or upon Run! Day Camp For Dogs, LLC premises and while my pet is under the care of Run! Day Camp For Dogs, LLC.
2. I hereby assume full responsibility for any harm caused by my pet while in or upon Run! Day Camp For Dogs, LLC premises and while my pet is under the care of Run! Day Camp For Dogs, LLC. I further agree to indemnify Run! Day Camp For Dogs, LLC for any loss, liability, damage, or costs they may incur due to any harm caused by my pet.
3. I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the States of Oregon and Washington, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
4. I further understand and agree that in admitting my pet to Run! Day Camp For Dogs, LLC, the owners of Run! Day Camp For Dogs, LLC have relied on my representation that my pet is in good health and has not harmed or shown aggression or threatening behavior toward any person or pet.
5. I agree that should a court determine that any provision is deemed unenforceable, Run! Day Camp For Dogs, LLC liability shall be limited to the funds paid to me by it for taking care of my pet.
6. I further understand and agree that any injury or illness that develops with my pet will be treated as deemed best by Run! Day Camp For Dogs, LLC, and that I assume full financial responsibility for any and all expenses involved, even if such expenses were later found to be unnecessary, furthermore, should my pet pass away during my absence we direct that a veterinarian may be called to safe keep our pet until I return.
7. I acknowledge that my pet will be playing off-leash, with a group of dogs, in an area that is completely unsecured and where hazards such as roads, wild animals, and potential poison exist. I understand that Run! Day Camp For Dogs, LLC has relied on my representation that my pet has sufficient obedience training to come to Run! Day Camp For Dogs, LLC when called using the command "Come." Should my dog fail to come when called I assume immediate responsibility for regaining possession of my pet.
